
Job Profile – Gas Contracts Manager - Building Services

- Pay Range Band 13 - £60,906 - £68,200
- Line manager M&E and Lifts Contracts Manager - Building Services

- Location Civic Offices, Portsmouth (Hybrid working available) Role is office based at least 3 days per week; you will need to be able to travel as required between PCC Assets in Portsmouth, Havant, Gosport, Fareham and Winchester.

Job purpose

We are seeking a Gas Contracts Manager as part of our Compliance service within Building Services of the Housing, Neighbourhood and Building Services Directorate.

The role will have responsibility for managing strategic Term Service Contracts in relation to gas repair, servicing and compliance activities. Specifically, the role will have responsibility for the contract management and service delivery of our Gas Servicing, Repairs and Compliance Contract in relation to our HRA stock of 17,000 dwellings.

The role will hold responsibility for the overall management of the gas contracts ensuring that contracts are suitably procured and managed, delivering a high-quality service and providing value for money, whilst continually seeking to delivery service improvement.

The role will also assume responsibility for ensuring policies and procedures are in place, relevant to the service area and to ensure that they are implemented so that statutory responsibilities are met with the safety of residents, members of the public, staff and our buildings being maintained.

The role will support the M&E and Lifts Contracts Manager to oversee the M&E contracts including the gas servicing and repairs contract ensuring that servicing, repairs and maintenance are undertaken correctly to the HRA stock of 17,000 and 900 corporate assets.

What is the role?

- To ensure the robust management of Term Service Contracts in relation to gas servicing and repair.
- To ensure that PCC meet its statutory compliance duties and ongoing operation of buildings to its HRA residential stock of nearly 17,000 dwellings and 900 corporate assets.
- To provide advice to designers, technical professionals and contractors when designing and installing new gas appliances.
- To work to continually improve the service and strive for 100% compliance in all service areas, leading work with other service areas within the directorate to overcome issues such as difficult access.
- To ensure that compliance certification and documentation is accurate, robust and suitably stored to evidence compliance.
- To ensure robust management of service budgets within your area, c.£4m per annum, to deliver value for money.
- To develop, implement, monitor and review policies and procedures in relation to compliance activities within the scope of the role.
- To remain up to date with changes to legislation and the wider industry to ensure that PCC are meeting its statutory duties, ensuring the ongoing safety of residents, members of the public and staff accessing its Buildings. Keep up to date with changes in the industry to be able to effectively horizon scan to identify emergency issues and ensure a suitable response.

- To lead the procurement of strategic service contracts and frameworks relevant to the service area ensuring that suitable contractor and consultant resources are in place to meet the operational needs of the service.
- To work with members of the compliance service, Heads of Service and Assistant Directors to ensure that effective compliance activities, servicing and repairs are undertaken to support the service delivery needs.
- To advise the Head of Compliance of servicing and repair demand which may inform capital works programmes.
- To facilitate training and support across Building Services and the wider Council to ensure staff have a relevant understanding of Gas Safety Compliance activities and their duties within their role and technical support.
- To liaise with stakeholders and responsible persons for buildings, advising them of their duties with regards to Gas Safety.
- To provide technical input into the relevant compliance panels.
- The role will form part of the Directorates Out of Hours Escalation Process and will be required to be on a rota to respond to Building Services issues that may arise out of hours when on rota.

Who is the person?

The ideal candidate is someone who will:

- 1 Have a relevant property related degree in a relevant building, engineering or technical subject area and preferably be a Chartered Member or working towards a relevant professional body. Where candidates are not Chartered or hold lower qualifications, they should be able to demonstrate relevant experience in a similar role.
- 2 Have ACS domestic gas qualifications in CCN1, CENWAT, CKR1 and HTR1, together with relevant practical experience in a similar role.
- 3 Have excellent technical knowledge of gas safety and installation within the scope of the role, being able to identify statutory requirements, assess quality of works and be able to provide professional advice to others.
- 4 Have experience of managing strategic service contracts, ideally with knowledge of Schedule of Rates Contracts and NEC 4 Term Service Contract suite.
- 5 Have experience of the procurement of term service contracts including the development of scope of service documentation, contracting models and evaluation of bids in line with Public Procurement Regulations.
- 6 Have experience of managing significant budgets including monitoring and cost control techniques to ensure services are delivered within available budgets.
- 7 Excellent practical knowledge of relevant legislation and technical guidance, including, The Gas Safety (Installation and Use) Regulations 1998, The Control of Asbestos Regulations 2012, Health and Safety at Work etc. Act 1974 and the Building Regulations and relevant Approved Documents.

- 8 Have experience of preparing and developing strategies, policies and guidance documents to ensure compliance with statutory functions.
- 9 Have knowledge and experience recording and analysing compliance data on relevant compliance IT systems, using measures to monitor performance and inform service improvement.
- 10 Have experience of leading and managing teams, including continual improvement of both staff and service delivery.
- 11 Experience of working with and communicating with a wide range of stakeholders including Directors, Assistant Directors, and other senior staff across the council and external organisations. Building and maintaining relationships as required.
- 12 Ability to use different IT packages including Microsoft (Excel, Word and Project) to analyse data, prepare reports, correspondence and specifications and bespoke PCC repairs and maintenance database to input repairs and stock data.
- 13 Personally demonstrate, develop and work in accordance with the value and behaviours set out in the PCC Behaviour Framework.
- 14 Have a driving licence and provide a car for work to be able to effectively travel to assets as necessary.

Ways of working

This is not a typical 9am - 5pm office-based role. A number of your services operate 24 hours, 7 days a week delivering repairs and maintenance. You will be a manager that is visible and takes a keen interest in spending time in the work to see the service being delivered. You will also be as interested in the service offer and delivery within 'office' hours as that provided 'out of hours.'

The Housing, Neighbourhood, and Building Services Directorate aspires to be a 'Systems Thinking Directorate' and uses the Vanguard Systems Thinking method in its approach to the leadership and management of services and as a continual improvement method.

Customer related purposes have been established for each aspect of the repairs and maintenance service and will continually seek to achieve them.

- Right repair at the right time - Repairs
- Maintain and improve our property - Capital Projects
- Provide suitable homes when needed - Voids Service

The core role of any manager within the Directorate is to understand and act on the system of work to drive improvement.

This will include:


- Ensuring all staff have clarity of understanding about the purpose of the service from the customer's point of view.
- Ensuring we understand customer demand.

- Use of robust measures of performance to make visible the customer experience.
- Understanding the flow of work in the service to ensure we keep teams, and individuals, focussed on what is valuable to the customer; and,
- Acting on the system in response to obstacles experienced by customers and staff.

You will create an environment that enables change to occur based on learning, and will support, educate, and develop staff to equip them to do better work.

Working hours - Contractual hours are 37 hours per week. Business operational hours are 8am to 6pm with core hours between 9:30-12:00 and 2pm-4pm, but there will need to be flexibility to reflect the fact that most services are provided 24 hours, 365 days of the year. There may meetings outside of these hours, and the need to react to emergencies out of core hours.
