The Service

Solent Growth Partnership team are Portsmouth City Council (PCC) employees working on behalf of the partnership and have responsibility across the wider geography and report under the Economic Development and Skills service in the Economy, Transport and Planning Directorate. The home base for work is Portsmouth Civic Offices and regular attendance at this, and sites across the 3 unitary authorities of Isle of Wight, Portsmouth and Southampton

Solent Growth Partnership (SGP) is the functioning economic area including Isle of Wight (IOW), Portsmouth and Southampton unitary authorities. Created in April 2024, following the closure of Local Enterprise Partnerships (LEPs) the partnership works across the unitary authority areas to ensure the economic prosperity of the region.

What is the role?

- Responsible for the delivery of projects across the partnership are, including projects and
- Reporting to Head of Economic Development and Skills in Portsmouth City Council as the accountable body
- Identify and secure new income generation activities through national and local networks, developing funding bids when necessary to sustain the self supporting service
- Account management of key relationships with partners, including economic development colleagues across the area, prime contractors / commissioning organisations and key businesses
- Ensure the effective delivery of contracts to meet targets and ensure the sustainability of provision
- Manage the financial claims and reporting requirements of all contracts to ensure sustainment of the service
- Commissioning and quality assuring delivery by any 3rd parties to ensure all contract requirements met and best practice ensured in all delivery.
- Budget management for the small delivery team
- Lead on the development and commissioning of new programmes and services
- Driving and developing a wide-ranging portfolio of projects designed to deliver the aspirations of the Solent Growth Partnership



- Work collaboratively with key partners, particularly all 3 unitary authority Economic Development teams, surrounding Economic Development representatives from districts and boroughs, DWP and other government departments.
- Prepare and review business reviews to senior managers and the Solent Growth Partnership board.
- Positively marketing the Solent Growth Partnership and prosperity across the region
- Acting as an advocate for Solent Growth Partnership in all interactions
